

The resource packs created by CinderaceOTS or SzandorThe13th (from now on referred to as the “Creator”) are not licensed to users, but may be used freely as long as they comply with the following terms and conditions.

Article 1 (Scope of Application)

These terms and conditions apply to all resource packs created by the Creator, including those from the former Community Works channel on the Minecraft Transit Railway discord server.

For vehicles that have been pull-requested into the Minecraft Transit Railway (hereinafter referred to as MTR) mod and have been merged, these terms and conditions do not apply, as they inherit the MIT license of the MTR mod.

Article 2 (Usable Acts)

1. This vehicle can be freely modified as long as it does not violate prohibited acts.
2. In principle, permission from the Creator is not required to redistribute modified vehicles, but we would be very grateful if you could report their use.
3. When redistributing, please include a credit and a link to this resource pack.
 - a. Although it is not required, distributing only the modifications at the time of distribution can reduce client-side resources. If distributed in this way, please state that the resource pack carrying this license needs to be installed.
4. When redistributing, please specify a license that does not conflict with these terms and conditions. If you are unsure, you can link this license to inherit its terms.

Article 3 (Prohibited Acts)

The user must not do any of the following when using this resource pack:

- 1. Using this content to represent or recreate an accident or any other insensitive situation**
- 2. Using this content for commercial purposes**
- 3. Using this content for religious or political purposes**
- 4. Redistributing this content without any modifications (except for redistribution for the purpose of incorporating it into a multiplayer server or distributed world)**
- 5. Acts that violate laws, regulations, public order or morals**
- 6. Acts related to criminal acts**
- 7. Acts that cause disadvantages, damage or discomfort to other users or third parties**
- 8. Acts that violate the terms of use of the MTR discord server**
- 9. Using this resource pack for AI training**
- 10. Unless specified otherwise, porting this content to any form of media other than MTR, whether inside or outside Minecraft (for example RTM or BVE)**
- 11. Other acts that are deemed inappropriate**

Article 4 (Suspension of Distribution)

1. The Creator may suspend distribution of the resource pack without prior notice to users if he or she determines that any of the following reasons are applicable:
 - a. It has become difficult to continue distribution and/or management of the resource pack due to external causes such as earthquakes, lightning, fires, power outages or natural disasters.
 - b. The prohibited acts described in Article 3 occur too frequently.
 - c. It is otherwise determined that it has become difficult to distribute the resource pack.
2. When distribution is stopped, we may request that distribution of modified resource packs be stopped as well. **Please be sure to follow the instructions in case this happens.**
3. The Creator is not to be held liable for any disadvantage or damage caused to third parties due to the suspension of distribution of this resource pack.

Article 5 (Restrictions and Prohibitions of Use)

1. The Creator may restrict or prohibit the user from using all or part of this resource pack without prior notice if the user meets any of the following conditions:
 1. **The user has violated any of these terms and conditions**
 2. The user has violated the terms of use of the MTR discord server
 3. The Creator deems the user's application of the resource pack to be inappropriate in any way
2. Regarding Minecraft multiplayer servers, if a member of the server, such as a builder, violates the terms and conditions in a situation where the resource pack is publicly available, the server may, in principle, be restricted or prohibited from using this resource pack until a server moderator or staff member reports that action has been taken against the violator. This however, does not apply to the following multiplayer servers that one of the Creators belongs to.
 1. MTR Let's Play Server (LPS)
 2. MTR Japan Server (MJaS)
 3. United Cities Railways (UCR)
3. The Creator is not to be held liable for any disadvantage or damage caused to users as a result of action being taken as stated above.

Article 6 (Disclaimers and Other Matters)

1. The Creator is not to be held responsible for any damage caused by usage of this resource pack.
2. By downloading this resource pack, you agree to these terms of use.
3. The content in this resource pack may be changed at any time. If there are any changes that might cause compatibility issues, the user will be notified in the changelog.

4. These terms may be revised or deleted at any time at the discretion of the Creator.
When revisions are made, he or she will notify the public via discord.
